Know all men by these presents that I Thomas Newport of the County of Worcester in Maryland yeoman, for and in consideration of the sum of ninety pounds and five shillings to me in hand paid before the sealing and delivery of these presents by Jesse Newport of the said County yeoman, the receipt whereof I do hereby acknowledge, I have bargained and sold, and by these presents do bargain and sell unto the said Jesse Newport all the goods household stuff and implements of household, and all other goods whatsoever mentioned in the schedule hereunto annexed now remaining and being, to say, my improvement team and cart, and four cows and three calves, and fifteen hogs and two potts and one periagua and a new chest and one old feather bed, one coverlid, one blanket, one sheet, and one catstail bed, one coverlid, one blanket, one sheet, two crosscut saws, and four bee hives, and two ploughs and one harrow, and (betle?) rings, and three iron wedges, and one mattock, and one grubbing hoe, three weeding hoes, four old axes, one spade, one old gun now remaining and being in the possession of Jesse Newport. To have and to hold all and singular the said goods, household stuff, and implements of household and every of them by these presents bargained and sold unto the said Jesse Newport his executors administrators and assigns forever. And the said Thomas Newport for myself my executors and administrators all and singular the said goods and household stuff unto the said Jesse Newport his executors administrators and assigns against me the said Thomas Newport my executors administrators and assigns and against all and every other person and persons whatsoever shall and will warrant and forever defend by these presents of which goods I the said Thomas Newport have put the said Jesse Newport in full possession by delivering him all the above mentioned goods at the time of the sealing hereof. In witness whereof I have hereunto set my hand and seal this twenty second day of November one thousand Thomas Newport (seal) seven hundred and fifty six.
